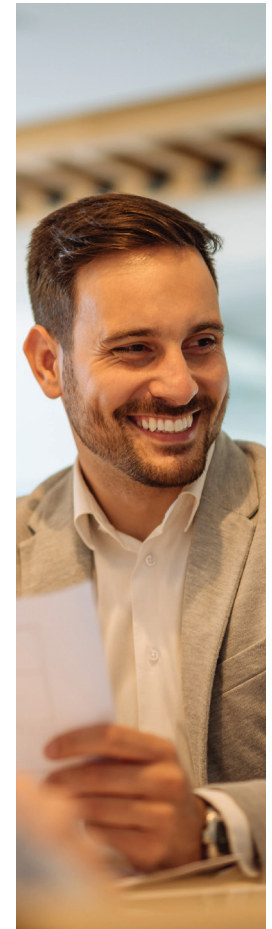

We recommend this to clients who have not previously engaged a qualified valuer to assess insurance value.

Insurance Reviews

This review ensures that your existing assets are adequately covered by your current insurance.

Desk-top Revaluation

We offer this as part of a long-term insurance valuation program where our team provides re-evaluation of your insurance to ensure proper coverage.

With our vast experience in insurance valuations, we know that getting it right involves obtaining an understanding of our clients' business and assets..

Property Drug Swab Testing

As the national public health concern around the manufacturing and consumption of illicit substances increases, Acumentis saw an opportunity to provide our clients peace of mind when it comes to the health of their property.

We have partnered with South Australian based SwabFirst - developers of a market leading illicit drug testing system.

The team at Acumentis are authorised and trained sample collectors, with swabs taken during routine valuations and add about 30 minutes to the inspection for the typical

house. Samples are sent to the SwabFirst laboratory and a report is provided within 48 hours confirming if any harmful drug residue is present, enabling clients to make informed decisions.

Our service focuses on the swab collection only and we remain independent from any remediation service providers.

Our service will assist;

- Real estate agents, investors, relocation agents and large companies wanting to ensure duty of care for employees and tenants.
- Prospective home buyers or renters, to provide confidence the property is safe for occupancy.
